• **Selection fee:** 20,000 yen (※The selection fee is not repayment.)

• Application method:

- 1 Mail : You send the filing document by EMS, and you need to remit selection fee to the appointed bank account. (※Please pay the charge own expenses.)
- 2 When you bring it directly to this school :
You prepare the filing document and the selection fee, and contact us before you will come to school.

• **Acceptance period:**

Monday - Friday (8:30 am ~ 17:00 pm)

◆Matters to be attend to:

- 1 The period for each certificate is three months.
- 2 Please submit all originals to the document.
- 3 If the documents written in own language, please attach a Japanese translation.
At the end of the translation, please fill out the address, name and phone number of the translator, and please put their seal.
- 4 The group name, the address, and the telephone number must use the printed form for each certificate.
Please put representative and publisher's name, stamping, and telephone numbers at the end of the certificate.
- 5 Please copy beforehand and keep the necessary one because originals of applications are submitted to Immigration Bureau.

- 1 Application form (Sheet:① 1~3)
- 2 Covenant (Sheet:②)
- 3 Diploma or certificate of graduation of the final coming from school
- 4 The record certificate of the final coming from school.
- 5 Proof of studying Japanese
 - * Certificate that Japanese language school issued
(Necessary items: The study period, the study time and the result.)
 - * Certificate of Japanese Language Proficiency Test / The copy of transcript.
- 6 Incumbency or leaving certificate
 - * Need to: In service the period and the job content.
- 7 Graduate expectation certificate / Student registration certificate
(Person who is on the register in high school or university.)
At the time of leaving school before graduation: Unit acquisition certificate etc.
 - * Need to: On the register period, Matriculation number, Date of birth, and Major faculty subject
- 8 Photograph: 4 pieces (4 x 3 cm)
 - * It is necessary to take the photograph within three months.
 - * Fill in the nationality, the name, and date of birth on the reverse.
- 9 Copy of passport (It is unnecessary when not acquired yet.)
 - * Submit the copy of all pages.
- 10 If you are enrolled in primary school in the 7-year-old or less, shall be submitted the statement of the reasons.

※ The filling in document must be an autograph of the applicant yourself.

(All family's documents)
 - * The copy of family registration book, and resident.

- 5 The copy of bank passbook (past three years) or the proof of deposit formation process.
- 6 The certificates of employment
 - * Company employee: The certificate of employment issued by the company representative.
(It has been noted that tenure, position, and job description.)
 - * Self-management / Management: The copy of business license (Color) .
- 7 The proof of earnings
 - * Of the past three years from the current fiscal year.
- 8 The tax certificate
 - * Of the past three years from the current fiscal year.

●If the sponsor lives in Japan

- 1 Financial support document (Sheet-③)
- 2 The oath (Sheet-④)
- 3 The resident of all household
 - * Foreign nationality: The alien registration card
- 4 The seal registration certificate
- 5 The annual income certificate (Of the past three years from the current fiscal year.)
 - * Salaried worker: The income certificate issued by the city government office.
(No withholding)
 - * The declared income: The income certificate or the copy of final return issued by the tax office. (The document must have a sign of tax.)
- 6 The vocational certification
 - * Company employee: The certificate of employment issued by the company representative.
 - * Self-management / Management: The copy of the registration that contains the name and trade name, or the operating license, the copy of final return.
(The document must have a sign of tax.)
- 7 The certificate of deposit balance
